1. The Bhokraha Narsingh Rural Municipality **has allocated funds** towards the cost of Construction of Black Top Road and intends to apply part of the funds to cover eligible payments under the Contract **for Following**. Bidding is open to all eligible as per Section V of bidding document..
2. Bhokraha Narsingh Rural Municipality invites Electronic bids from eligible bidders for the construction of Black Topped Road under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of www.bhokrahamun.gov.np or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. A Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

6. Pre-bid meeting shall be held at Rural Municipality Office at 2077-05-07 at 2.00pm.
7. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12.00 pm on 2077-05-23. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2077-05-23 at 2.00 pm at the Rural Municipality office. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format e-bid, amounting to a minimum of bid security for 120 days as follows.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
